

## **THE WHOLE LEARNING SCHOOL VOLUNTEER DRIVER APPLICATION**

Field trips are a vital part of the educational program at The Whole Learning School (TWLS), and we often look to parents for assistance in transporting students. In the interest of ensuring that all of our students are safe, and also on the recommendation of the school's insurance carrier, we are instituting more thorough driver screening procedures. We hope that you will fill out this form and provide the required documentation so that you are available as a field trip driver.

**TWLS, acting on the advice of its insurance carrier, seeks to prohibit the following drivers from serving as volunteer drivers for school activities:**

- 1) A driver with any one of the listed "Serious Violations" committed in the last three years or with more than two of these violations committed between three and eight years ago.

Serious Violations

- a) DWUI/DWI - Drugs or Alcohol
  - b) Hit and Run
  - c) Failure to Report an Accident
  - d) Negligent homicide using a motor vehicle
  - e) Driving while license is suspended or revoked
  - f) Using a motor vehicle for the commission of a felony
  - g) Permitting an unlicensed person to drive
  - h) Reckless driving
  - i) Speed Contest
  - j) Illegal passing of a school bus
- 2) A driver with any combination of accidents (regardless of fault) and other moving violations which total three during the previous three years.
  - 3) A driver without a valid U.S. license.
  - 4) A driver licensed less than three (3) years regardless of age.
  - 5) Any driver who is not licensed in the state where they reside within the required time.
  - 6) Drivers 21 years of age or younger.
  - 7) Any driver who carries less than the state-required minimum insurance levels:
    - a) \$30,000 bodily injury liability to one person in any accident; \$60,000 bodily injury liability to two or more persons in any accident;
    - b) \$10,000 property damage liability;
    - c) \$25,000 uninsured and underinsured motorist coverage for injury/death to one person in any accident; \$50,000 uninsured and underinsured motorist coverage for injury/death to two or more persons in any accident.

**In applying to be a volunteer driver for The Whole Learning School activities, I agree to the following statements:**

- I warrant that I do not fall into any of the categories listed in numbers 1-7 above.
- I agree to transport students only in a vehicle that is in safe operating condition.
- I understand that my own insurance coverage is the first and primary coverage in case of any accident.
- I agree to provide documentation to TWLS upon request, including the following:
  - A copy of my driver's license;
  - A copy of the front page of my insurance coverage;
- I authorize TWLS to perform a check of my Motor Vehicle Record (MVR) if the school has any concerns about my driving record.
